

MARINE DEPARTMENT NOTICE NO. 72 OF 2009

(Marine Works)

Submarine Cable Laying Operations
from Deep Water Bay to Waters East of Hong Kong

With immediate effect until 26 June 2009, submarine cable laying operations will be carried out along a line from Deep Water Bay to the eastern boundary of Hong Kong Waters. The line is formed by joining the following co-ordinates (WGS 84 Datum):

2. The works will be carried out by one cable-laying barge, two tugs and two motor boats. The number of vessels engaged in the works will change from time to time to suit operational requirements.

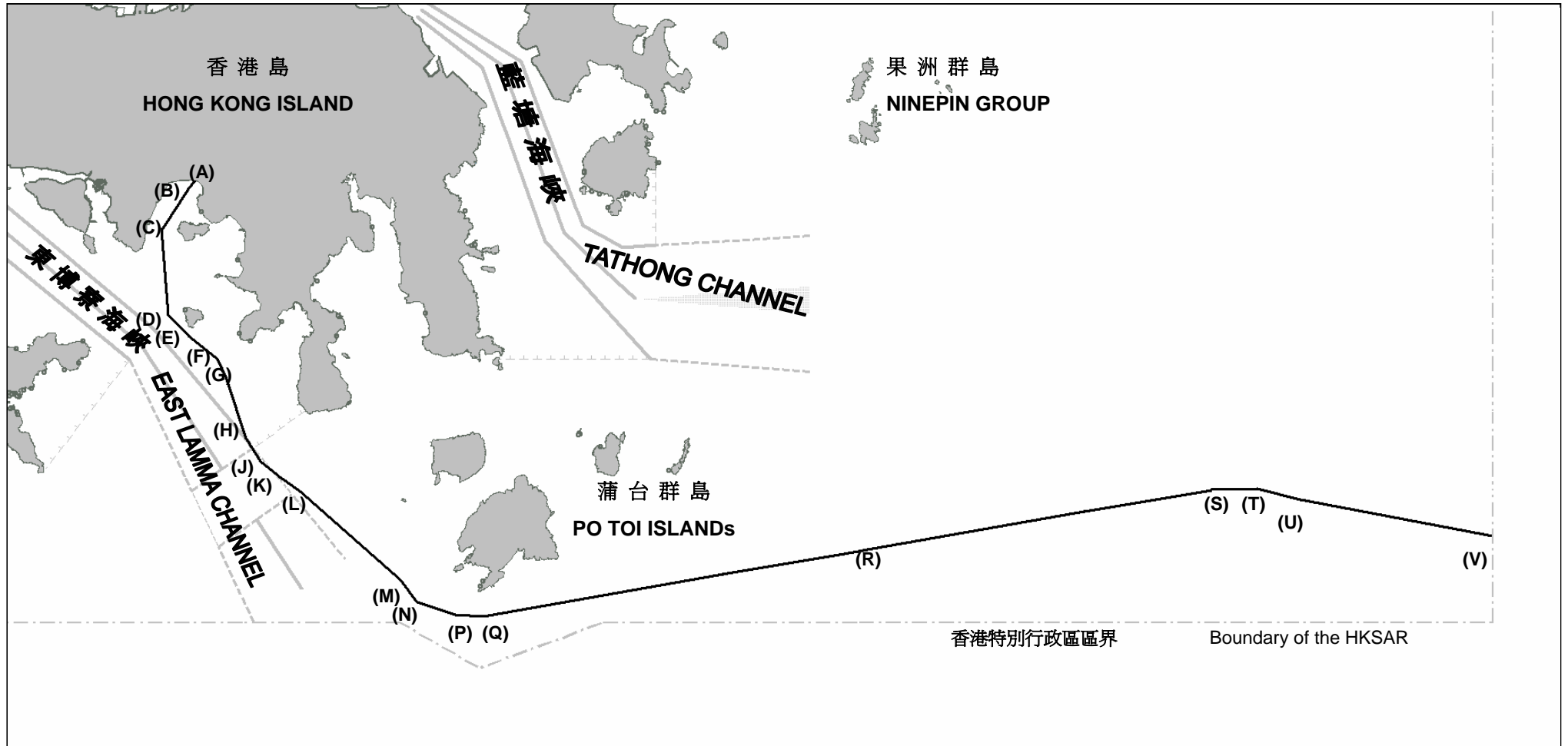

3. A working area of approximately 300 metres around the cable-laying barge will be established. The working area may be extended from time to time to suit operational needs. Yellow marker buoys fitted with yellow flashing lights will be laid to mark the positions of the anchors extending from the cable-laying barge.
4. The works will normally be carried out round-the-clock.
5. Vessels engaged in the operations will display signals as prescribed in international and local regulations.
6. Diving operations will be carried out from time to time.
7. Vessels navigating in the vicinity should proceed with caution at a slow speed and keep clear of the cable-laying barge, bearing in mind that there are divers working in the area.
8. A drawing showing the cable alignment is attached to this Notice.
9. This Notice is an extension of Marine Department Notice No. 44 of 2009.
