

MARINE DEPARTMENT NOTICE NO. 85 OF 2010

(Marine Works)

Removal and Laying of Private Moorings in Aberdeen South Typhoon Shelter

With immediate effect and for a period of approximately two months, marine works involving removal and laying of private moorings will be carried out in Aberdeen South Typhoon Shelter in the following areas:

Area 1: This area is bounded by straight lines joining the co-ordinates (WGS 84 Datum) from (A) to (D):

(A)	22° 14.321' N	114° 09.655' E
(B)	22° 14.332' N	114° 09.699' E
(C)	22° 14.237' N	114° 09.722' E
(D)	22° 14.228' N	114° 09.675' E

Area 2: This area is bounded by straight lines joining the following co-ordinates (WGS 84 Datum) from (E) to (M):

(E)	22° 14.490' N	114° 09.714' E
(F)	22° 14.513' N	114° 09.785' E
(G)	22° 14.518' N	114° 09.858' E
(H)	22° 14.469' N	114° 09.913' E
(J)	22° 14.390' N	114° 09.908' E
(K)	22° 14.330' N	114° 09.858' E
(L)	22° 14.306' N	114° 09.746' E
(M)	22° 14.356' N	114° 09.727' E

Area 3: This area is bounded by straight lines joining the following co-ordinates (WGS 84 Datum) from (P) to (T):

(P)	22° 14.295' N	114° 09.752' E
(Q)	22° 14.323' N	114° 09.866' E
(R)	22° 14.309' N	114° 09.870' E
(S)	22° 14.304' N	114° 09.866' E
(T)	22° 14.280' N	114° 09.756' E

2. One dumb lighter will carry out the works. Two tug boats and some motor boats will provide assistance. The working vessels will change their locations from time to time to suit operational requirements.
3. A working area of approximately 30 metres will be established around the dumb lighter. Yellow marker buoys fitted with yellow flashing lights will be laid to mark the positions of the anchors extending from the dumb lighter.
4. The hours of work will be from 0700 to 1900 hours. No works will be carried out on Sundays and public holidays. The vessels employed for the works will stay in the works areas outside the hours of work.
5. Diving operations will be carried out from time to time during the hours of work.
6. Vessels engaged in the works will display signals as prescribed in international and local regulations.
7. Vessels navigating in the vicinity should proceed with caution and keep clear at slow speed, bearing in mind there are divers working in the areas.
8. A drawing showing the works areas is attached to this Notice.
9. This Notice is an extension of Marine Department Notice No. 20 of 2010.

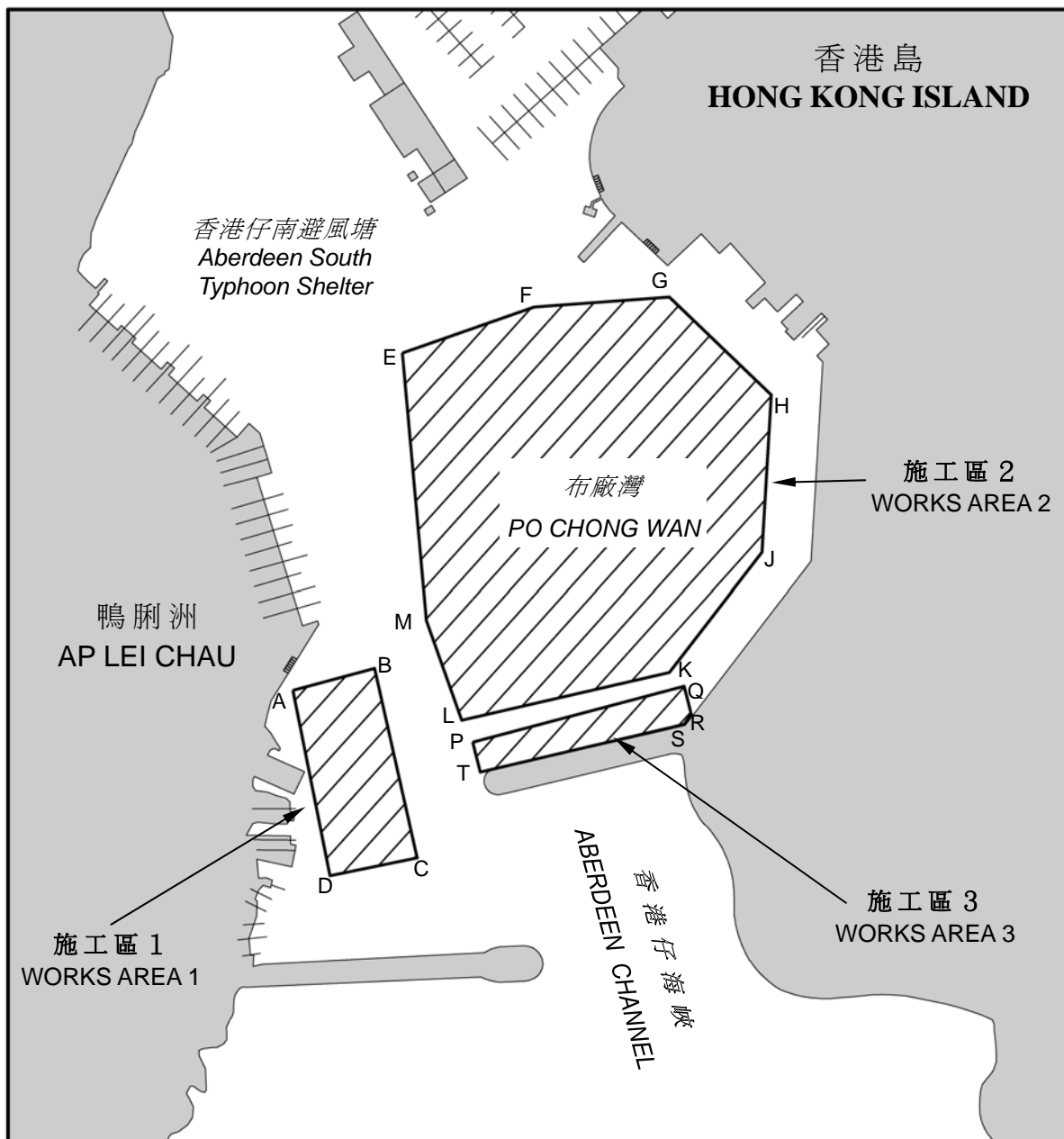
