- 6. The applications for authorization as a surveyor are processed by batches. Normally, an applicant will be notified of the result of his application within four months after his application is received by the Marine Department. In the event that an application requires a longer time to process due to some special circumstances, e.g. verification of non-local qualifications, the applicant will be duly informed of the progress of his application.

<u>The minimum qualification/experience requirements and</u> <u>continuous professional development requirement</u> <u>for authorization as a surveyor</u>

(A) Qualification requirements (last updated in 2014):

- (a) Registered as a Registered Professional Engineer (Marine and Naval Architecture Discipline) and having his name on the register established under section 7 of the Engineers Registration Ordinance (Cap 409); or
- (b) The qualifications acceptable to the Director of Marine for the recruitment by MD as a Surveyor of Ships. According to the current qualifications requirements of Surveyor of Ships, applicants are required to meet the requirements in one of the three categories below:

Category A

- (i) a degree in engineering or technology relevant to the work of the surveyor of ships; or Corporate Membership of the Hong Kong Institution of Engineers (Marine & Naval Architecture Discipline) or equivalent; <u>and</u> a Certificate of Competency (Marine Engineer Officer) Class 1 issued by or acceptable to the Director of Marine; or
- (ii) a Certificate of Competency as Extra First Class Marine Engineer Officer acceptable to the Director of Marine; or
- (iii) a degree in Mechanical / Marine Engineering or equivalent; Corporate Membership of the Hong Kong Institution of Engineers (Marine & Naval Architecture Discipline) or equivalent; and a Certificate of Competency (Marine Engineer Officer) Class 2 issued by or acceptable to the Director of Marine.

Category B

- (i) an Extra Master's Certificate of Competency acceptable to the Director of Marine; or
- (ii) a degree in Nautical Studies or related subject acceptable to the Director of Marine; and a Certificate of Competency (Deck Officer) Class 1 (Master Mariner) issued by or acceptable to the Director of Marine.

Category C

(i) a degree in naval architecture or related technology acceptable to the Director

of Marine; and

 (ii) Corporate Membership of the Hong Kong Institution of Engineers (Marine & Naval Architecture Discipline) with specialization in the naval architecture field or equivalent.

<u>Note 1</u>

Applicants with academic qualifications other than those obtained from Hong Kong institutions/Hong Kong Examinations and Assessment Authority are required to have their non-local qualifications accredited by the Hong Kong Council for Accreditation of Academic and Vocational Qualifications.

(B) Experience requirements:

At least 4 years' maritime practical experience (Note 2) as the Director considers appropriate, including either:

- 9 months accumulated practical experience gained in the field specified in (d) of Note 2, or
- (ii) totally 1 year accumulated practical experience gained in the fields specified in (a) to (d) of Note 2, with at least three months experience gained in the field specified in (d) of Note 2.

Note 2

The "maritime practical experience" means accumulated working experience in the field of maritime professional such as marine engineering and/or naval architecture, including:

- (a) marine engine and system maintenance or repairing, operation inspection or technical services of vessels;
- (b) ship design or structural construction or ship-repairing/ maintenance;
- (c) teaching/training/regulatory/management;
- (d) plan approval, or inspection or survey of newly-built or existing vessels including structural part inspection, the testing of engine, system and equipment installations.

(C) Continuous professional development requirement

The applicant is required to, in the preceding 12 months, have participated in at least 30 hours' of the continuous professional development activities which are stipulated in the relevant guidance notes of the Hong Kong Institute of Engineers (HKIE).
