- (a) The Marine Department (“MD”) Government New Construction Section (“GNC”) Supplier lists are intended for mailing purposes (where applicable) only. None of the GNC’s notifications of quotation invitation for the supply of vessels (“Notifications”) shall give rise to any right or expectation on the part of the GNC Suppliers (“Suppliers”) or any obligation on the part of the Government of the Hong Kong Special Administrative Region (“Government”). The Government makes no statement, representation or warranty (express or implied) to Suppliers that the Notifications or any of them will be uninterrupted, timely, secure, or error free. For open tenders, the Suppliers should read the tender notices published in the Government Gazette and the website of MD.
