**United Nations Sanctions (Democratic People's Republic  
of Korea) (Amendment) Regulation 2013**

(Made by the Chief Executive under section 3 of the United Nations Sanctions Ordinance (Cap. 537) on the instruction of the Ministry of Foreign Affairs of the People's Republic of China and after consultation with the Executive Council)

**1. United Nations Sanctions (Democratic People's Republic of Korea) Regulation amended**

The United Nations Sanctions (Democratic People's Republic of Korea) Regulation (Cap. 537 sub. leg. AE) is amended as set out in sections 2 to 6.

### Explanatory Note

This Regulation amends the United Nations Sanctions (Democratic People's Republic of Korea) Regulation (Cap. 537 sub. leg. AE) (*principal Regulation*) to give effect to certain decisions in Resolution 2087 (2013), as adopted by the Security Council of the United Nations on 22 January 2013, by amending the definition of *specified item* in section 1 of the principal Regulation to cover additional items set out in the International Atomic Energy Agency documents INFCIRC/254/Rev. 11/Part 1 and INFCIRC/254/Rev. 8/Part 2 and the Security Council document S/2012/947.

2. The Regulation also makes certain minor amendments.
