HONG KONG MERCHANT SHIPPING INFORMATION NOTE

Adoption of Performance Standards for Shipborne MF and MF/HF Radio Installations capable of Voice Communication, Digital Selective Calling and Reception of Maritime Safety Information and Search and Rescue related Information

To : Shipowners, Ship Managers, Ship Operators, Ship Masters, Classification Societies and Shipbuilders

Summary

This Note promulgates IMO Resolution MSC.512(105) on performance standards for shipborne MF and MF/HF radio installations capable of voice communication, digital selective calling and reception of maritime safety information and search and rescue related information.

- 1. The Maritime Safety Committee (MSC) of the International Maritime Organization (IMO), at its 105th session on 28 April 2022, adopted the Resolution MSC.512(105) on revised performance standards for shipborne MF and MF/HF radio installations capable of voice communication, digital selective calling and reception of maritime safety information and search and rescue related information. The MF and MF/HF radiotelephone, digital selective calling (DSC) and reception of maritime safety information (MSI) and search and rescue (SAR) related information installation, in addition to meeting the requirements of the SOLAS regulations IV/9, 10 or 11, should comply with the relevant ITU-R Recommendations and the general requirements set out in resolutions A.694(17), MSC.191(79), as amended and the latest requirements in Resolution MSC.512(105).

- 3. Shipowners, ship managers, ship operators, ship masters, classification societies and shipbuilders of Hong Kong registered ships are advised to ensure that shipborne MF and MF/HF radio installations capable of voice communication, digital selective calling and reception of maritime safety information which will form part of the GMDSS:

- (a) if installed on or after 1 January 2024, conform to performance standards not inferior to those specified in the annex to Resolution MSC.512(105);
- (b) if installed on or after 23 November 1996 but before 1 January 2024, conform to performance standards not inferior to those specified in the annex to resolutions A.804(19), as amended, and A.806(19), as amended, or conform to performance standards not inferior to those specified in the annex to Resolution MSC.512(105); and
- (c) if installed before 23 November 1996, conform to performance standards not inferior to those specified in the annex to resolutions A.610(15) and A.613(15).
