Submarine Cable Laying Operations
from Chung Hom Kok to Waters East of Hong Kong

With immediate effect and for a period of approximately seven months, submarine cable laying operations will be carried out along the following co-ordinates (WGS 84 Datum) from (A) to (V):

2. The works will be carried out by a flotilla of vessels including one dumb lighter, one flat-top work barge, one special purpose vessel and three tugboats. The number of vessels engaged in the works will change from time to time to suit operational requirements.
3. A working area of approximately 50 metres around the lighter and barge will be established. Yellow marker buoys fitted with yellow flashing lights will be laid to mark the positions of the anchors extending from the lighter and barge.
4. The hours of work will be from 0700 to 1900 hours. No works will be carried out on Sundays and public holidays. Vessels employed for the works will stay in the area outside the hours of work.
5. Diving operations will be carried out from time to time during the hours of work.
6. Vessels engaged in the operations will display signals as prescribed in international and local regulations.
7. Vessels navigating in the vicinity should proceed with caution and keep clear of the area at slow speed, bearing in mind there are divers working in the area.
8. A drawing showing the alignment of the cable is attached to this Notice.

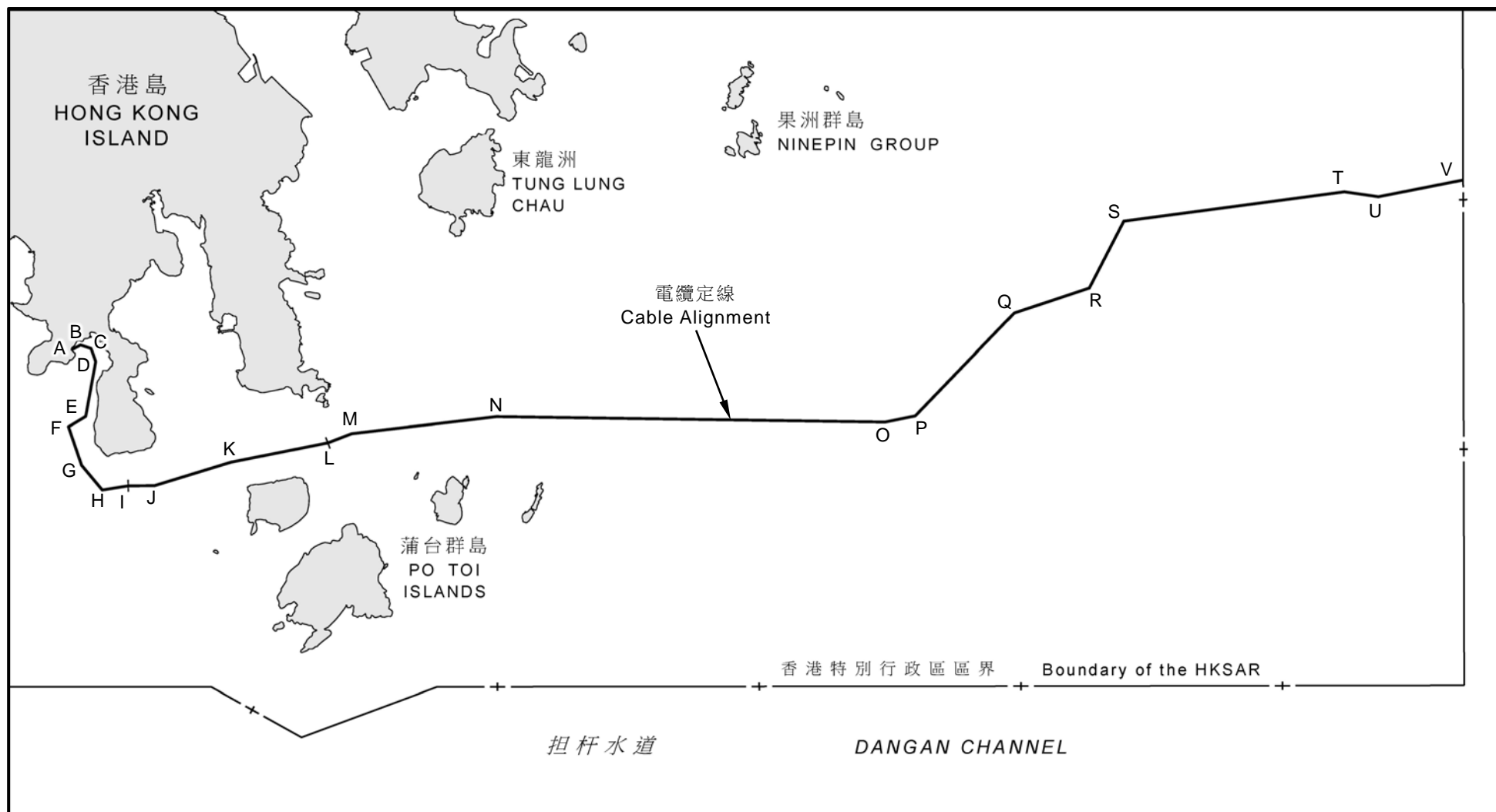
