(Miscellaneous Information)

Arrangement for Authorized Surveyors Employed by Recognized Fishing Vessel Survey Organizations to carry out Plan Approval and Survey for Hong Kong licensed Class III Vessels in Mainland

This Notice is to announce the arrangement that certain qualified surveyors employed by fishing vessel survey organizations recognized by 廣東省海洋綜合執法總隊 (執法總隊) (Recognized Fishing Vessel Survey Organizations, or RFVSOs) are authorized as Authorized Surveyor (AS) under the Merchant Shipping (Local Vessels) Ordinance (Cap. 548) to conduct plan approval and survey for Hong Kong licensed Class III vessels operating in the Mainland (Hong Kong Mobile Fishing Vessels).

- 2. The Marine Department (MD) has since 2002 recognized 廣東漁業船舶檢驗局 (the present 執法總隊) to conduct plan approval and survey for Hong Kong Mobile Fishing Vessels in accordance with the Merchant Shipping (Local Vessels) (Safety and Survey) Regulation (Cap. 548G).
- 3. Starting from the end of 2020, the plan approval and survey of fishing vessels which were used to be carried out by 執法總隊 have been gradually taken up by RFVSOs.
- 4. To cope with the above changes, the Director of Marine has authorized relevant qualified surveyors employed by fourteen RFVSOs to carry out plan approval and survey in the Mainland for Hong Kong Mobile Fishing Vessels starting from 9 September 2022. The information (in Chinese only) of the fourteen RFVSOs, their contact details, the ASs and the authorized scope of work are listed in the Annex of this notice. The list is also promulgated on MD's website (https://www.mardep.gov.hk/en/home.html) and will be updated as and when required.

The Survey Procedure of the above Arrangement

- 5. The arrangement of plan approval and survey work will be similar to the current practice. The shipowner shall forward a copy of the completed Notice of Engagement form to MD prior to conducting the work, and specify the AS and the concerned RFVSO in the form.
- 6. The AS shall submit relevant Declaration of Survey and other related documents to MD on satisfactory completion of plan approval and survey of a Hong Kong Mobile Fishing Vessel. Upon the acceptance of the Declaration of Survey, MD will issue the Certificate of Survey to the vessel.

Fees

7. The fees incurred for the plan approval and survey of vessels shall be settled between the shipowner and the RFVSO engaged by the shipowner.
