(Marine Works)

Marine Site Investigation at Junk Bay

With immediate effect and for a period of approximately six months, marine site investigation works involving drilling of boreholes will be carried out in the following locations (WGS 84 Datum):

2. The works will be carried out by one flat-top work barge, two jack-up barges and one work boat. One tug will provide assistance. Vessels engaged in the works will display signals as prescribed in international and local regulations.

3. A working area of approximately 50 metres around each barge will be established. Yellow marker buoys fitted with yellow flashing lights will be laid to mark the positions of the anchors extending from the flat-top work barge. Yellow flashing lights will be installed at the four corners of the jack-up barges to indicate its position.
4. The hours of work will be from 0800 to 1800 hours. No works will be carried out on Sundays and public holidays. Vessels employed for the works will stay in the works locations outside the hours of work.
5. Vessels navigating in the vicinity should proceed with caution.
6. A drawing showing the borehole locations is attached to this Notice. This Notice should be read in conjunction with Marine Department Notices No. 17/2022, 37/2022, 176/2022 and 6/2023.

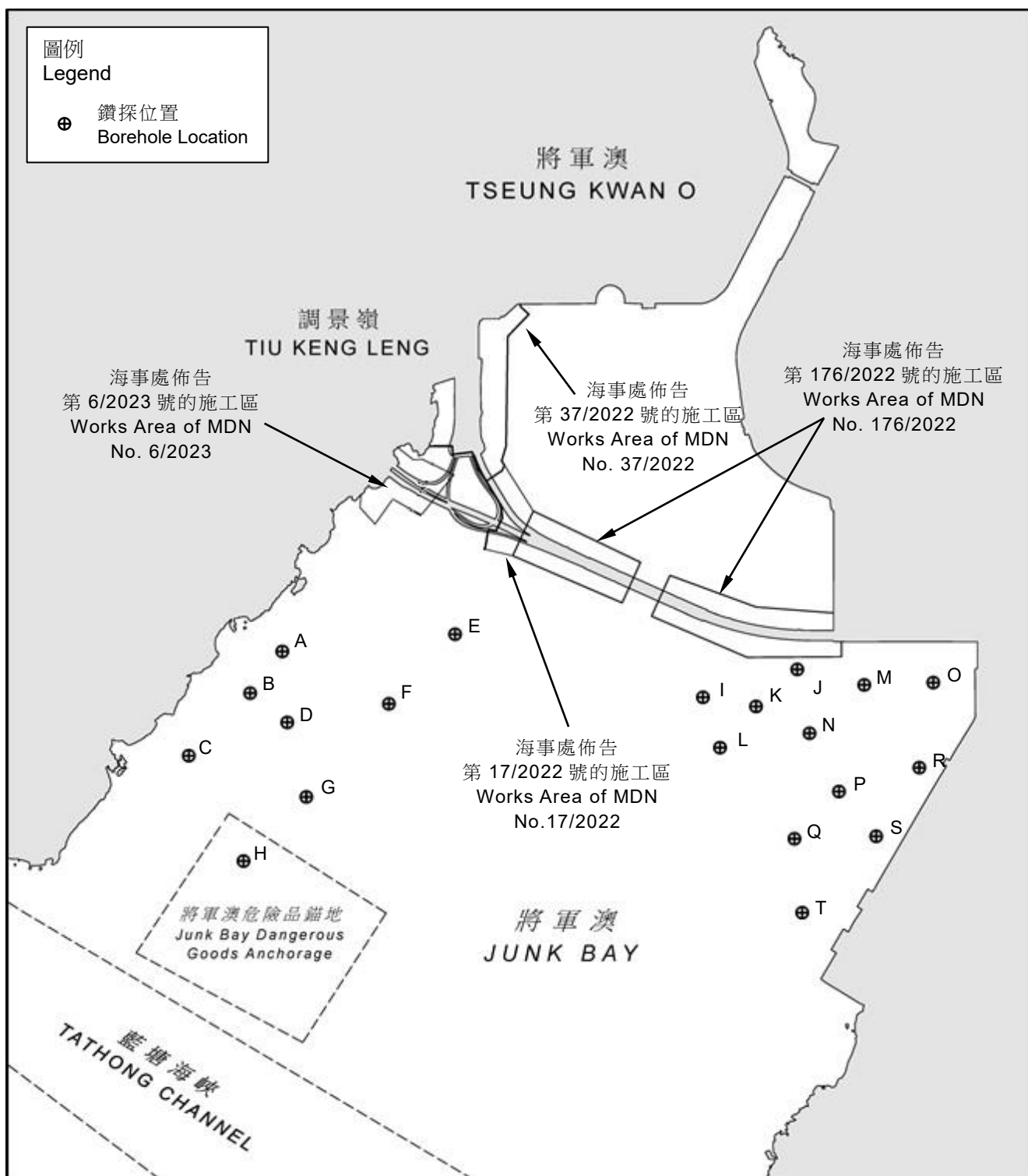
