## Hong Kong International Convention for the Safe and Environmentally Sound Recycling of Ships, 2009 (HKC) Issuance of "Statement of Compliance" (SoC)

Please be advised that the HKC will enter into force internationally on 26 June 2025. The Government of the Hong Kong Special Administrative Region (HKSAR) is currently preparing local legislation for the implementation of the HKC in the HKSAR.

Pursuant to Article 3.4 of the HKC, no more favorable treatment is given to the ships flying the flag of an administration that has not yet implemented the HKC. Therefore, HK registered ships (HK Ships) are required to comply with the provisions of the HKC when calling at ports of countries<sup>1</sup> that have implemented the HKC on and after 26 June 2025.

Before the HKC is implemented in the HKSAR, the owners of HK Ships may voluntarily request their Recognized Organizations to issue a SoC, together with this letter, to show to port States that their HK Ships are in compliance with the provisions of the HKC.

Pursuant to Regulation 5.2 of the HKC, existing ships shall have on board an Inventory of Hazardous Materials no later than 26 June 2030 (five years after the entry into force of the HKC) or before going for recycling if this is earlier. The initial and renewal survey of the HKC should be harmonized with the surveys required by other applicable statutory instruments of the IMO in accordance with Regulation 10.5 of HKC.

The SoC will be replaced with the International Certificate on Inventory of Hazardous Materials when the HKSAR has formally accepted the HKC.
