Application for the "Certificate of Insurance or Other Financial Security in Respect of Civil Liability for Wreck Removal" (WRC) Issued by Mainland Authority

This letter serves as a general reminder regarding the annual renewal of WRC issued by Shenzhen Maritime Administration (Shenzhen MSA) for Hong Kong registered ships. You may refer to No. 7/2015 of the Hong Kong Merchant Shipping Information Note for certification requirements.

2. In view of the anticipated large influx of applications near to the WRC renewal deadline and the forthcoming Lunar New Year holidays in China will be expected to commence from 15 to 23 February 2026, the following application arrangements will be adopted this year to ensure timely issuance of the WRC and placing the WRC onboard ship by your company:-

Please note that subject to further announcement by Shenzhen MSA, the office of Shenzhen MSA will be expected to close from 15 to 23 February 2026 for the Lunar New Year.

- 3. Having considered the aforementioned circumstances, it is anticipated that the processing and delivery time of the WRC to ship will exceed 10 working days. Expiry of current WRC before successful renewal is at Shipowners and Ship Managers' own risk. As such, you are encouraged to submit the application form with supporting documents on or before 31 December 2025 for catching the certificate collection schedule and delivering the WRC to ship on or before 20 February 2026.
- 4. Please note that only the applications submitted with all necessary documents will be processed. You are required to ensure accuracy and consistency of the particulars shown on the application form, the 'Blue Card' and the Certificate of Registry (CoR) to avoid delay in processing.
