Security and Quality Advisory No. 74 Security situation in the Black Sea and the Azov Sea

Recognizing the recent perspectives expressed by the shipping industry, we would like to bring your attention to the importance of ensuring the safety of navigation and security of shipping in and around the Exclusive Economic Zones and territorial waters of Ukraine and the Russian Federation in the Black Sea and the Azov Sea (Concerned Waters).

General Information

2. Masters, Ship Security Officers, Company Security Officers, Shipowners, and Ship Managers of Hong Kong Registered Ships (HK Ships) that are presently located in or intending to enter the Concerned Waters are strongly advised to undertake a comprehensive Risk Assessment, thoroughly review the prescribed responses outlined in the Ship Security Plan (SSP), and communicate with all relevant coastal States, port authorities, and port agents in order to acquire the requisite clearances and regional information. Failure to secure the necessary clearances and regional information may subject the ship to intolerable risks.
