Security and Quality Advisory No. 78 Security situation in the Red Sea

The recent escalating number of security incidents involving aerial drones and surface craft attacks on ships, as well as malicious electronic interference with shipboard navigation systems, indicates a significant and imminent threat of both direct and collateral damage to ships navigating the Red Sea (Concerned Water). This advisory seeks to draw your attention to the utmost importance of ensuring the safety of navigation and security for Hong Kong-registered ships (HK Ships) operating in and around the Concerned Waters.

- 3. As of 25 November 2024, IMO Secretariat recorded 69 incidents in an update on the situation in the Red Sea region (Annex I).
- 4. On 8 July 2025 IMO Secretary-General urged constructive dialogue amid renewed Red Sea attacks on merchant ships. These attacks have led to fatalities and injuries, violating international law and freedom of navigation. The risk of ships being attack in the Concerned Waters is high. Masters, Ship Security Officers, Company Security Officers, Shipowners, and Ship Managers shall take a detour and stay away from the Concerned Waters unless the elevated risk can be mitigated to a tolerable level.
- 5. Masters, Ship Security Officers, Company Security Officers, Shipowners, and Ship Managers of HK Ships currently located in or intending to enter the Concerned

Waters are hereby strongly urged to conduct a thorough and comprehensive Risk Assessment. It is imperative to establish and maintain communication with all relevant coastal States, port authorities, and port agents to obtain the necessary clearances and up-to-date regional risk information. Failure to secure such clearances and critical information may expose the ship and crew to intolerable risks. All crew members should maintain heightened vigilance at all times. The prescribed responses and measures outlined in the Ship Security Plan shall be strictly adhered to, and additional security measures should be implemented as deemed necessary to address the increased threat level.

6. HK Ships shall fly the proper colors when entering and leaving any port, and may fly the proper colors at other times as well. The proper colors shall be the national flag of the People's Republic of China directly above the regional flag of the Hong Kong Special Administrative Region (Annex II).
