## HONG KONG MERCHANT SHIPPING INFORMATION NOTE

Application for the issue of Hong Kong Licences and GMDSS Certificate of Equivalent Competency under the International Convention on Standards of Training, Certification and Watchkeeping for Seafarers, 1978 (STCW), as amended

To: Shipowners, Ship Masters, Agents and Seafarers' Unions

## Summary

The purpose of this Note is to inform shipowners, ship masters, agents and seafarers' unions about updated "Guidelines for the Issue of Hong Kong Licences to holders of non-Hong Kong Certificates under the International Convention on Standards of Training, Certification and Watchkeeping for Seafarers, 1978, as amended" and "Guidelines for the Issue of GMDSS Certificate of Equivalent Competency with Endorsement for Recognised Foreign GMDSS Radio Certificate Holders and Certificate Endorsement Revalidation". The HKMSIN No. 27/2009 and No. 28/2009 issued on 23 October 2009 are hereby superseded.

- 1. The "Guidelines for the Issue of Hong Kong Licences to holders of non-Hong Kong Certificates under the International Convention on Standards of Training, Certification and Watchkeeping for Seafarers, 1978, as amended" (referred as "Guidelines for Licence") are updated from time to time and published on the website of Marine Department including list of STCW countries that are recognized by this Administration for the issue of full term or short term licences and the fees for the issue of such licences. Please refer to the updated "Guidelines for Licence" in the link: https://www.mardep.gov.hk/en/pub\_services/pdf/coc\_gl4.pdf.
- 2. The "Guidelines for the Issue of GMDSS Certificate of Equivalent Competency with Endorsement and Certificate Endorsement Revalidation" (referred as "Guidelines for GMDSS") are also updated and published from time to time including list of STCW countries that are recognized by this Administration for the issue of full term or short term GMDSS Certificate of Equivalent Competency (CoEC). For the officers holding a recognized STCW certificate of competency and an appropriate and valid GMDSS radio operator certificate, they may apply for a GMDSS operator endorsement together with the Hong Kong Licence. A stand-alone STCW GMDSS certificate of equivalent competency is not necessary anymore while the seafarer obtains a Hong Kong Licence with GMDSS operator endorsement.

To expedite the processing and issuance of Hong Kong Licence, applicant is 4. strongly recommended to apply Hong Kong Licence on-line through the Marine Department Electronic Business System (eBS) by referring to Appendix 2 of the "Guidelines for Licence".
