HONG KONG MERCHANT SHIPPING INFORMATION NOTE

Amendments to the International Convention for the Safety of Life at Sea, 1974, as amended

To : Shipowners, Ship Managers, Ship Operators, Ship Masters, Classification Societies and Shipbuilders

Summary

The purpose of this Note is to promulgate IMO resolution MSC.550(108) and to advise the parties concerned of the amendments to Chapter II-2 and Chapter V of the International Convention for the Safety of Life at Sea ("SOLAS"), 1974, as amended which will enter into force on 1 January 2026.

- 1. The Maritime Safety Committee (MSC) of the International Maritime Organization (IMO) at its 108th session adopted the resolution MSC.550(108) on 23 May 2024 to amend the SOLAS. The amendments will enter into force on 1 January 2026.
- 2. Main amendments to Chapter II-2 and Chapter V of SOLAS are summarized as follow, amongst others: -
