2. The works will be carried out by one special purpose vessel and one dumb lighter. Three tugboats will provide assistance. The number of vessels engaged in the works will change from time to time to suit operational requirements. Vessels engaged in the works will display signals as prescribed in international and local regulations.

3. A working area of approximately 50 metres around the dumb lighter will be established. Yellow marker buoys fitted with yellow flashing lights will be laid to mark the positions of the anchors extending from the dumb lighter.

4. The hours of work will be round-the-clock.

5. Diving operations will be carried out from time to time during the hours of work. Vessels navigating in the vicinity should proceed with caution and keep clear of the works area at slow speed, bearing in mind that there are divers working in the area.

6. A drawing showing the alignment of the cable is attached to this Notice.

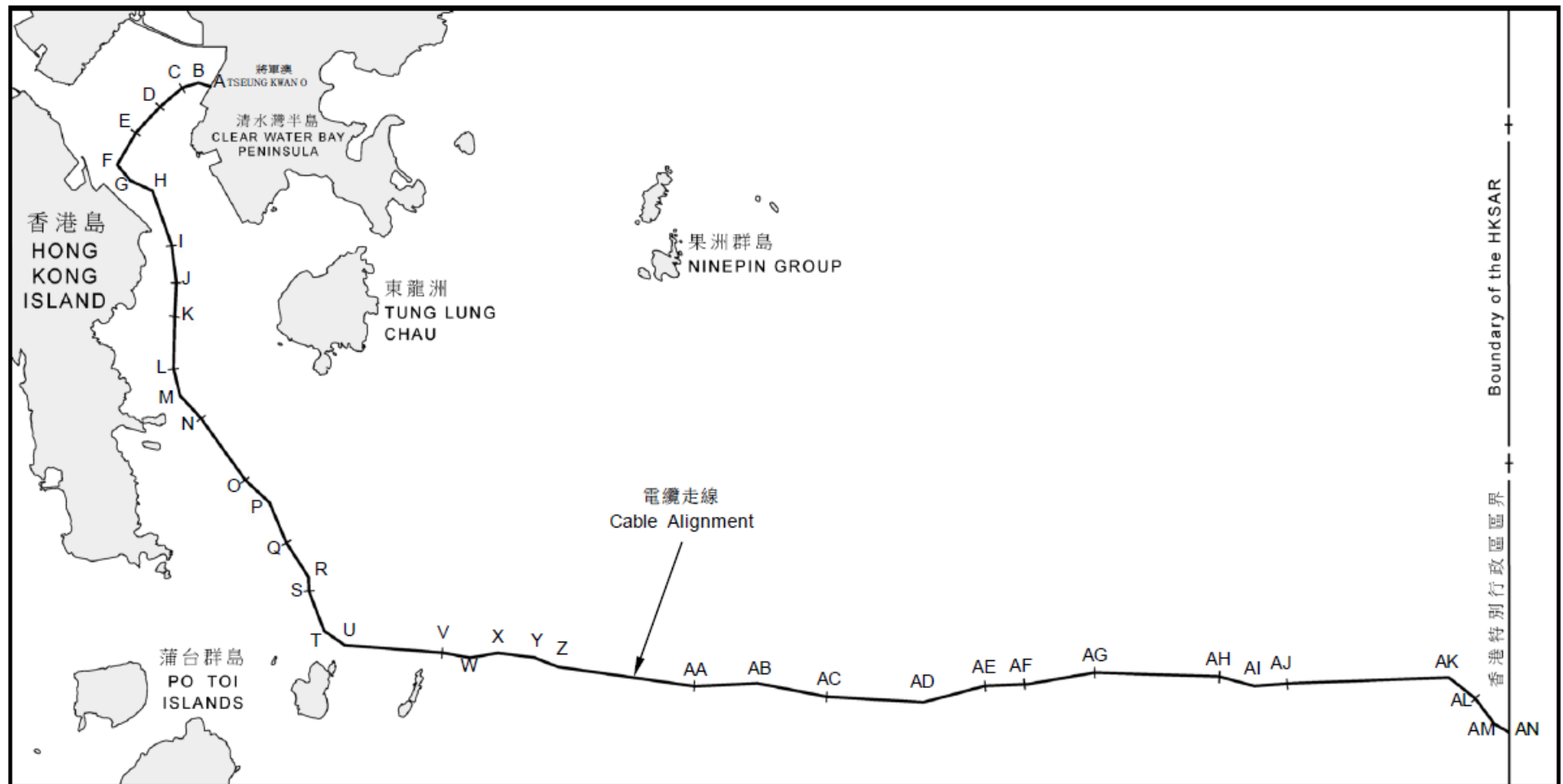
