Purpose:

This document explains the quantity of Electronic Navigation Equipment (ENE) to be provided as Spare Parts.

(a) Paragraph 9.2.7 of Part VII – Technical Specifications of MDST 5/2022 states:

9.2.7 In addition to all the Operational Systems [viz INS listed in Paragraph 9.3 of this Part VII, all other ENE listed in Paragraph 9.4 of this Part VII and all other communication systems] that the Contractor is required to provide for each Vessel under Chapter 9 of this Part VII, the Contractor shall also provide one complete set of these Operational Systems (one set equal to the same quantities as installed on one Vessel) as **Contract Spare Parts in Schedule 1**. In the event that any equipment is substituted during the Contract Period, the Contractor shall supply one (1) set of the substitution equipment as spare parts.

Explanatory Notes:

Above (a) Paragraph 9.2.7 of Part VII – Technical Specifications provided the definition of **one** (1) shipset of Electronic Navigation Equipment as <u>Contract Spare Parts</u> stated in Item 16, Part 2 – Spare Parts of Schedule 1 - Price Schedule to Part V.

Above (b) Item 16, Part 2 – Spare Parts of Schedule 1 - Price Schedule to Part V specified **two (2)** shipsets of Electronic Navigation Equipment are required.

In gist, the total quantity ENE to be supplied in the tender is (i) **one (1) shipset** shall be supplied and installed on each vessel; and (ii) **two (2) shipsets** shall be supplied as **Spare Parts**. Paragraph 9.2.7 has no intention to demand an additional quantity of ENE on top of the Price Schedule.
