Tenders must be prepared and submitted in two separate envelopes as “Envelope A” and “Envelope B” for “Price Information” and “Technical Proposal” respectively as specified in Clause 4 of Part II Terms of Tender of the tender documents. Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the “Chairman, Tender Opening Committee, Government Logistics Department” and deposited in the Government Logistics Department Tender Box situated on the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong, before 12:00 noon (Hong Kong Time), on 6 May 2024 (Monday). Late tenders or submission by fax, or tenders not deposited in the specified tender box will not be accepted.

Electronic Tendering

Tenderers submitting tender via the e-Tender Box (ETB) must be through the use of an Identification Code or any one type of digital certificates recognised by and uploaded to the ETB. - : 1. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
