Submission of Tender	: Paper-based Tendering Tenders must be prepared and submitted in a sealed envelope as “Envelope C” comprising two separate envelopes as “Envelope A” and “Envelope B” for “Price Information” and “Technical Information” respectively as specified in Clause 2 of Part 1 Terms of Tender of the tender documents. Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the “Chairman, Tender Opening Committee, Government Logistics Department” and placed in the Government Logistics Department Tender Box situated at the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong, before 12:00 noon (Hong Kong time), on 25 July 2025 (Friday). Late tenders or submission by fax, or tenders not deposited in the specified tender box will not be accepted.
